Applications are invited from the eligible Retired Railway Loco Pilots in prescribed format as Annexure –I along with relevant documents for re-engagement for undertaking CRC/PRC/TLC duties in Madurai Division.

Eligibility Criteria:

01	No. of posts	11
02	Who are eligible to apply	Retired Loco Pilots preferably retired from MDU division. It may be noted staff who have been compulsory retired on safety shall not be reengaged for the scheme. Retired employee being re-engaged, should not have been covered under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARGESS).
03	Medical fitness	Must be found medically fit in appropriate category.
04	Age limit	Maximum age limit for such re-engagement shall continue to be 65 years.
05	Remuneration	Monthly remuneration to be governed by Rly.Bd.Letter.No. E(NG)II/2007/RC-4/CORE/1 dtd:24.10.2019 PCPO/MAS PBC.No.258/2019 dtd:12.11.2019. The re-engaged retired staff are not entitled for any other benefit or facilities except monthly fixed remuneration.
06	Documents to be attached (Self attested)	a) Copy of Service Certificate b) Copy of Pension Payment Order (PPO) c) Copy of Last Pay slip d) Copy of Savings Bank account Pass Book, PAN and e) Two copies of passport size photo (Not later than 03 months)
07	Application Format	Application to be submitted as per proforma in Annexure -I along with documents mentioned above. Ineligible and incomplete applications and applications without necessary enclosures will not be considered.
08	Applications to be sent to	Divisional Personnel Officer/ Southern Railway / MDU Division
09	Last date to apply	31.03.2024.

Procedure of Re-engagement:

Volunteering eligible retired Loco Pilots will be called for document verification and screening by the Competent Authority i.e., Sr. DEE/OP. If found suitable for re-engagement in all respects, such shortlisted candidates shall be sent for medical examination in appropriate medical category.

General Conditions.

- a) Re-engagement is purely on temporary basis and reengaged retired staff will be terminated as and when suitable regular incumbents join the post either by way of recruitment or by transfer or on attaining the age of 65 whichever is earlier, on cessation of the scheme or due to surrender of post due to Man Power Planning.
- b) Such re-engaged Loco Pilots can be terminated after giving a notice period of one month.
- c) Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.
- d) Re-engaged retired staff will not have the right for continuity/extension of reengagement.
- e) In case of absence of duty, proportionate amount of remuneration per day will be deducted.
- f) The TA/DA shall be payable as per extant rules.
- g) The re-engagement is subject to the orders issued by Railway Board from time to time.
