Ref: RB letter No.2016/E(LL)/AT/EPF/1 dated 12.08.2016.

A preventive check was conducted in a Running Room at TPJ Division, on the aspect of Monitoring compliance to instructions on Minimum Wages Act in the Execution of manpower contracts, which is falls under Thrust Area 1.(o) for the year 2022 issued by Board Vigilance. The vigilance investigation revealed following irregularities,

1. Contractor hadn't paid the EPF contribution of contract employees deployed at Running Room, but contractor had submitted **forged** 'EPF payment conformation receipt' for the period of March-2021 to November-2021 for the purpose of claiming the payment from Division.

Hence in this Contract, there was clear violation of EPF & MP Act and this was not properly checked by the Railway officials while processing the bill for payment and accepted the forged document submitted by the contractor.

Vide letter under reference, Railway Board and EPFO had given guidelines and instruction in connection with implementation of EPF & MP Act, 1952 for workers on Railway Contracts. The letter says that "before passing of bills, the concerned authorities need to ensure that PF deductions have been credited to the EPF by all the contractors/sub-contractors." This can be verified through EPFO public portal https://unifiedportal-epfo.epfindia.gov.in/publicPortal/.

Hence it is requested that necessary advise may be issued down the line to all officials to ensure strict compliance of all the Labour laws vis-à-vis Minimum Wages Act, EPF & MP Act including updating of labour data in the "Shramik Kalyan Portal".

This issues with the approval of SDGM & CVO/S.Rly.



Employees Provident Fund Organisation administers the Employees' Provident Funds & Miscellaneous Provisions Act, 1952 and the schemes framed thereunder which aim to provide social security in the form of Provident Fund, Pension & Insurance to all the employees who are employed for wages in any kind of work, manual or otherwise in or in connection with the work of establishment and who get wages directly or indirectly from the employer and which includes any person employed by or through a contractors. EPF & MP Act, 1952 applies to an establishment engaging 20 or more number of employees and engaged in one of the scheduled activities notified under the Act. The issue of coverage of contract workers under the EPF & MP Act, 1952 has been flagged as an area of top most concern and priority by the Government of India. In this connection, I invite your personal attention towards deposit of Provident Fund by contractors of Indian Railways.

Our Country is a Welfare State and EPF & MP Act, 1952 is one of the most important social security legislations of the country. The Indian Railways engages large numbers of contract workers through outsourced agencies in course of operation and maintenance of its network. Being a part of the Government, Indian Railways need to ensure the implementation of EPF & MP Act, 1952 as a model employer, which is a beneficial social security legislation enacted by the Government, for its contract employees, independently coverable under the law.

As such I would request you to kindly issue appropriate circular instructions to all your field formations to ensure proper implementation of EPF & MP Act, 1952 for the employees on Railway contracts. I would also like to request to direct your field formations to share contractor and contract details on the portal of EPFO_i.e. www.epfindia.gov.in. While awarding contracts, it needs to be ensured that contractors have obtained PF code numbers and before passing bills, the concerned authorities need to ensure that requisite PF deductions have been credited to the EPF by all the contractors/sub-contractors. This can be verified by logging on to the EPFO portal by the principal employers. This shall go a long way in fulfilling the mandated statutory requirement and ensuring Social Security to large section of deserving workers.




