A check has been conducted based in CSD/PER, on the aspect of any irregularity in Inspection of materials by TPI agencies.

Polychloroprene Rubber pad for 25 KW Brushless Alternator (PL No: 45901065) has been indented with description including the names of the acceptable make as per RDSO approved list in abbreviated form as below.

"Polychloroprene Rubber pad for 25 kW Brushless Alternator of size 210 x 240 mm, 18 mm thick, black color, shore Hardness shall be 70 plus or minus 5, conforming to RDSO Drawing No. SKEL 4021 Alt.2 Shelf Life: 1 Year. Makes acceptable: BASANT, AK, MRI, FAIVELY, DEW, MGM, ELORA, RAY ELASTOMER, SRI, PI ENGINEERING, CGC, AMEENJI only." [Warranty Period: 30 Months after the date of delivery]"

Offers have been received from Swan Rubber Industries and Supreme Rubber Industries, both mentioning SRI as their make but only SWAN Rubber industries is a RDSO approved supplier. Since SRI has been included in the description of the material, developmental order has been placed to Supreme Rubber Industries by the purchasing official.

These materials supplied by Supreme Rubber Industries got failed for Hardness Test conducted in NABL Lab by Vigilance to ensure Quality.

Abbreviations in the description of materials caused confusions and lead to accepting ineligible offers resulted in receipt of materials of poor quality.

Hence in this regard it has been advised to revise all the descriptions of the stock items to avoid abbreviated forms of supplier/MAKE/BRAND.

Further the present description followed by SR for Polychloroprene Rubber pad of 25 KW brushless alternators as mentioned below,
