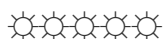

Applications are invited from willing and eligible retired railway staffs for re-engagement for **two posts of Sr. Section Officer (A) and two posts of Sr. Accountant (erstwhile Accounts Assistant) in Accounts Department of Tiruchchirappalli Division, Southern Railway**, on contractual basis on fixed monthly remuneration.

The **scheme of re-engagement** of Retired Railway Staffs on contractual basis will remain in vogue for an initial period of **two years** from the date of issue of instruction (**or**) till further orders, whichever is earlier. Engagement period of an individual retired staff will be for a period of **01 year (or)** till further orders, whichever is earlier. However, based on satisfactory performance of a re-engaged retired staff, his/her period of engagement can further be extended for a further period of **one year** or till attainment of **65 years** of age, whichever is earlier. The terms and conditions, instructions for the same is enclosed as **Annexure-A**.

The application duly filled in the prescribed format, should be submitted to **Sr.DFM's Office/TPJ** in person or Ordinary Post or through Online Link.

ELIGIBILITY :

- 1. Retired Railway Employees who have worked in Accounts Department as Sr.SO(A)** (in Level 8 and 9) **and Sr. Accountant** (erstwhile Accounts Assistant in Level 6 and 7) **are eligible to apply.** However, in terms of Railway Board's letter dt. 20-06-2025, re-engagement of Non-Gazetted posts in Pay Level 1 to 9 may be filled by calling volunteers who retired from posts in the same Cadre/Category **up to three level higher than the post** against which re-engagement is being considered,
- 2. Maximum age limit for re-engagement shall be 65 years.** Retired employees having **less than one year to attain 65 years of age, need not apply.**
- 3. Retired staff applying for re-engagement should be medically fit** in the appropriate category/post and the **medical fitness certificate** should be obtained from the designated authorities as per existing practices.
- 4. Willing retired railway employees are advised to carefully read the entire instructions and information attached as Annexure-A before** filling up the application.
- 5. Unsigned applications, applications received without affixing latest photograph and relevant documents will be treated as invalid/ineligible.**

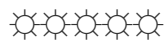

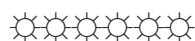

TERMS & CONDITIONS FOR RETIRED NON-GAZETTED STAFF
AGAINST VACANT POSTS ON CONTRACTUAL BASIS

1. Non-Gazetted Railway staff retired in Pay Level 1 to Pay Level 9 for re-engagement to the post held at the time of retirement to fill up vacant post(s) on contractual basis in various Departments of TPJ Division on fixed monthly remuneration.
2. **Remuneration** : A fixed monthly remuneration shall be admissible arrived at by deducting the Basic Pay Pension from the Pay Drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Annual increment/percentage increase and Dearness Allowance shall **not** be allowed during the contract period. (Example : For determining remuneration shall be, as given in DoE's OM No.F.No. 3-25/2020-E.IIIA dt. 09-12-2020).
3. **Maximum age limit** for which re-engagement staff shall continue, will be **65 years**.
4. Suitability/competency of the Retired Railway employees shall be adjudged on the basis of the last five APARs as per established norms for a DPC, before such re-engagement by a **three-member Committee** at an appropriate level duly taking into account safety and other operational requirement. While re-engaging such employees, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
5. The period of re-engagement shall be initially for a period of ONE year and further extendable as per requirement. **No** retired employees shall be engaged beyond the validity of the scheme.
6. The re-engagement of retired railway employees shall **not** be considered as a case of re-employment.
7. Paid leave of absence may be allowed at the rate of **1.5 days** for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case the engagement is extended. Also, no payment in lieu of unutilized leaves will be paid at the time of discharge/expiry of the contract.
8. The re-engaged employee shall not be entitled for HRA and residential accommodation. However, **Transport Allowance** for the purpose of commuting between the residence and the place of work shall be allowed **not** exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during

the term of appointment ; they may be allowed **TA/DA** on official tour, if any, as per their entitlement at the time of retirement.

9. The re-engaged employees **shall be given** responsibilities like inspections, supervision etc. and any other such duties as entrusted to them by the Immediate Superior concerned.
10. Each engagement should be decided on merits of the requirement and the suitability for the person for the job. The Committee should take in to account, the working experience of the staff so that they are useful for the purpose for which they are selected.
11. The re-engaged staff shall not be made in-charge of Units in the Division or in the Construction Unit. They shall **not** be given financial and D&AR powers and shall **not** be authorized to issue any safety certificate. However, they may recommend their suggestions on financial and other matters to regular or in-service staff/Officer.
12. The re-engaged employees shall not divulge any information gathered by him/her during the period of assignment related to the Organization to anyone who is not authorized to know/have the same and maintain Ethics and integrity at all times. For this purpose, the re-engaged staff shall **sign** an "Agreement of Confidentiality" with the Govt. of India containing a Clause on Ethics and Integrity.
13. The re-engaged staff should be discharged immediately on joining of selected candidate(s) from RRBs or through departmental selection or to any other reason, as per administrative convenience, based on the recommendation of PHOD/CHOD/DRM concerned.
14. The above re-engagement is governed by the Terms and Conditions as enumerated in Railway Board's letter No. E(NG)III/2024/RC-4/9 dated 15-10-2024, 31-12-2024 and 20-06-2025.



RE-ENGAGEMENT OF RETIRED EMPLOYEES OF VARIOUS DEPARTMENTS

– TERMS OF REFERENCE

As advised by Railway Board vide letter No.E(NG)III/2024/RC-4/9 dated 15-10-2024, 31-12-2024 and 20-06-2025, the Terms of Reference (TOR) of the work to be assigned for the re-engaged employees in various Departments is as under :

All the work normally assigned to the post held at the time of retirement in exigencies of the services for TPJ Division (e.g. Technician/JE/SSE) including any other works assigned by the competent authority except as follows :

1. The re-engaged employees shall not be made in-charge of Units in the Division **or** in the Construction Unit.
2. The re-engaged employees shall not be nominated in Selection Committee.
3. The re-engaged employees shall **not** be given the financial and D&AR powers and shall **not** be authorized to issue any safety certificate. However, they may recommend their suggestions on financial and other matters to regular or in-service staff/Officer.
