The Applicants who have registered with a local employment exchange falling in the state of Tamil Nadu and Kerala are eligible to apply. As a proof, candidate must enclose the copy of Service Certificate/Declaration from the Railway Employee which should be attested by the Gazetted officer of the concerned unit.

- (ii) Candidates selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control. After commencement of the training, the candidates have to execute a contract of Apprenticeship.
- (iii) Those who willfully absent themselves are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Adviser.

Application:

- (ii) One passport size photo should be pasted in the application in the space provided duly attested by Gazetted Officer.

vi) The colour photograph of 3.5cm x3.5cm (not earlier than three months from the date of application) with clear front view of the candidate without cap and sunglasses, should be pasted on the template in the space provided. Photostat copy of photo is not permitted. Administration may at any stage reject the application for pasting old/unclear photograph on the application or for any significant variations between photograph pasted in the application form and the actual physical appearance of the candidate. Candidates are advised to keep two additional copies of the same photograph ready for further process.

Last Date of application: The filled application should have reached to S&T/Work shop Podanur on or before **22-4-2016 17.15 hrs.** This Administration is not responsible for any postal delay and the belated applications will not be entertained under any circumstances.

Format of Application: Applications submitted in any format, other than the one provided by this Administration will not be entertained. Incomplete and unclear applications NOT in conformity with any of the conditions of this notification will be summarily rejected.

Applications without requisite enclosures will be summarily rejected.

MODE OF SELECTION:

Selection will be on the basis of merit list prepared in respect of all the candidates who apply against the notification. The merit list will be prepared by committee nominated for the purpose on the basis of percentage of marks in matriculation (with minimum 50% (aggregate) marks) plus ITI marks. In case of two candidates having the same marks, the candidates having older age shall be preferred. In case the dates of birth are also same, then the candidate who passed matriculation exam earlier shall be considered first.

Standard of Physical Fitness:

The candidates should be free from evidence of any contagious or infectious disease. The candidates should not be suffering from any diseases which is likely to be aggravated by service or is likely to render him unfit for training or to endanger of health of the public Candidate should be free from evidence of tuberculosis in any form (active or healed)

Vision should be no evidence of any morbid condition of either eye or the lids of either eye which may be liable to risk or aggravation or recurrence.

The candidates satisfies the minimum standard of physical fitness as prescribed in the Apprentices Act/Rules and the standard prescribed for imparting training to the relevant trades which will be certified by a Railway Doctor.

Higher Qualification:

Candidates with higher qualifications viz. Degree/Diploma holders/Engineering Graduates are not eligible to apply.

Transfer Certificate:

Original Transfer Certificate for completion of qualifying examination (Std. XII/ X/ VIII/ ITI) must be produced during verification of certificates. Transfer Certificate with higher qualifications will not be entertained.

Enclosures:

- (i) ORIGINAL CERTIFICATES should NOT be enclosed with the application.
- (ii) Necessary copy of certificate confirming pass in the course as on the date of the notification (VIII std , X Std mark list, Provisional Certificate/ National Trade Certificate (NTC) certificate/issued by NCVT in the case of ITI, to be enclosed. Mere completion of a course is not sufficient. Must and should enclose
- iii) Proof for date of birth
- (iv) Employment Exchange Registration No issued by the State of Tamil Nadu & Kerala for concerned trade
- (v) Candidates belonging to SC/ST/OBC communities should enclose a community certificate in the format prescribed by the Central Government. Further, in case of OBC candidates, the certificate should specifically indicate that the candidate does not belong to the person/Sections (Creamy Layer)

(vi) *Persons with Disabilities*: He/ She should enclose a Disability Certificate issued by the competent Medical Board.

OTHER CONDITIONS

(1) It should be noted that the selection and training are strictly in compliance with the provisions of Apprentice Act,1961 and **NO EMPLOYMENT IS GUARANTEED TO THE APPRENTICES ON COMPLETION OF THEIR TRAINING.**

1) The selected candidates should abide by the rules and regulations framed by the Administration from time to time.

2) If any declaration furnished by the candidate is found to be false, he/she will be disqualified /terminated at any stage of the training period.

3) Selected candidates will have to undergo training wherever training is prescribed for the engagement.

4) Every apprentice who have to completed their apprenticeship training and attend All India Trade test (to be conducted by the National Council for training in Vocational trades to determine the proficiency in the designated trade) and will be given a certificate of Proficiency in the trade by the National Council.

5) Candidates should possess the Academic/Technical qualification required for the relevant trade at the time of submitting their application. The applications of the candidates who are course completed but results waited/Certificates are awaited at the time of application will be rejected.


