ANNEXURE - A

CONDUCTIONS STIPULATED FOR RE-ENGAGEMENT

1. The maximum Age limit for re-engagement shall be 65 years or the validity of the scheme i.e.01.12.2019 which ever is earliest
2. The re-engagement is purely on temporary basis and the staff will be discharged as & when suitable regular incumbents join the post other by way of recruitment or by transfer or on attaining the age of 65 years whichever is earlier or on cessation of the scheme or due to surrender of post due to Man power planning or as and when the Rly Administration does not require the services by giving 15 days prior notice without assigning any reason.
3. Monthly remuneration of the re-engaged retired Railway Staff will be determined by reducing the original Pension from their Last Pay Drawn (i.e.Basic+DA) as per RBE No.150/2017 & 193/17 communicated under the PBC 192/2017 & 235/2017.
4. Suitability/Competency of the staff wherever required will be assessed before the re-engagement which include the Medical Fitness.
5. The applicants should not have been covered under the LARSGESS or any other like schemes. Cessation of the service should not be through DAR action as well.
6. The working hours of re-engaged staff will be same as that of the regular staff in similar post.
7. The remuneration will be on proportionate basis against the actual number of days worked and there is no entitlement of Leave/Rest/CR/Holidays or Allowances like TA etc.
8. The period of such re-engagement will not be counted as regular service for any purposes as admissible to regular Serving employees.
9. Re-engagement of staff will not be entitled for PLB or any other extra benefits admissible to serving employees.
10. Re-engaged staff will not be covered for any coverage under ECA,PWA. Payment off Gratuity Acct or any other statutory enactments admissible to serving Railway employees.
11. Re-engaged staff will not be covered by any of the Welfare Scheme. CGA,Ex-Gratia, Funeral Advance etc as admissible to regular employees.
12. Re-engaged staff will not be entitled for any Advances as admissible to regular employees.
13. The retired staff shall execute on agreement to abide by all the Terms &Condition for the re-engagement.
14. Selected candidate would be required to join work in 10 days in the event of selection being informed, failing which the selection will be treated as cancelled.
