Applications are invited from retired Railway Stenographers of Southern Railway who retired from service on or before 30.06.2018 for re-engagement as Stenographer against 18 vacancies of Southern Railway, Headquarters Office including Accounts Department (Reservation rules do not apply).

II. The following terms and conditions may please be noted.

1. Stenographers retired from Railway service are eligible to apply.
2. The reengagement shall be strictly upto age 65 years or till the availability of regular candidates from RRB or validity of the scheme i.e.01.12.2019 whichever is earlier as per Railway Board's letter No.E(NG)II/2007/RC-4/CORE/1 dt.16.10.2017 (RBE No.150/2017) & RBE No.193/2017 dt.12.12.2017).
3. The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct is found unsatisfactory or due to any other reasons.
4. In this scheme, Railway employees who are compulsorily retired or removed or dismissed from services are not eligible to apply.
5. The monthly remuneration of the re-engaged employees will be determined by reducing pension from his/her last pay drawn (i.e. Basic Pay + DA) and no other allowances/remuneration shall be payable in terms of Board's letter No.E(NG)II/2007/RC-4/CORE/1 dt.16.10.2017 (RBE No.150/2017).
6. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
7. Suitability/competency of the applicant shall be adjudged by a duly Constituted Committee for re-engagement.
8. Re-engagement shall also be subject to prescribed medical fitness for the Stenographer cadre.

9. Posting of selected candidates within Departments of Headquarters Office, Southern Railway would be decided by the competent authority. Selected candidates would be required to join within 10 days of their selection being notified, failing which their selection is liable to be treated as cancelled.

10. The normal Duty Hours of the re-engaged employee would be the same as applicable to ministerial staff.
