Applications are invited only from the Retired Railway Staff for re-engagement in the prescribed proforma enclosed.

Maximum age limit for such re-engagement shall be 65 years and this limit shall not be exceeded in any case. Their re-engagement is subject to the following conditions:

1	Retired employees being re-engaged should not have been covered under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guranteed Employmnet for Safety Staff (LARSGESS).
2	They should be found fit in the appropriate medical category for the posts against which they are re-engaged.
3	Suitability / competency of the staff will be adjudged by the concerned Branch Officers including the safety and other operational requirements as needed before re-engagement.
4	Retired staff of Railway Electrification will be given preference.
5	For Ministerial Staff/Peon at Sl. No.11,12 & 15, retired staff of any department in the same category will be considered.
6	Retired Staff from the same trade / Level will be given preference.
7	Retired Staff opting for the place of posting indicated in the Notification will be given preference.
8	If no adequate applicants are available fulfilling the conditions, any level of the categories can be considered as per the requirements / vacancies.
9	Monthly remuneration of a retired employee being re-engaged will be determined by reducing Pension from his/her Last Pay drawn (Basic Pay + DA) as per Railway Board's letter No. E(NG)-II/2007/RC-4/CORE/1 dt 16/10/2017 (RBE No.150/2017)
10	The services of the such re-engaged staff will be terminated at any time without notice.
11	They should be ready to work at any where in the Railway Electrification project of Southern Railway.
