

SOUTHERN RAILWAY**TERMS AND CONDITIONS FOR TRAINEES OF RAIL KAUSHAL VIKAS YOJANA:**

1. Candidates imparted training under "Rail Kaushal Vikas Yojana" will have **"No claim to seek employment on Railways on the basis of such training"**.
2. The application should be submitted in prescribed format with necessary documents.
3. Railway administration will not be liable to pay stipend to the trainees.
4. There will be **NO** communal reservation to the candidates under this scheme. The training will be conducted irrespective of religion, caste, creed or race.
5. Candidate will be allowed to avail training only in one trade at a time. No repetitive courses will be allowed to enable other candidates to get a chance for this training scheme.
6. Since it is a short duration course, 75% attendance is a must for completion of the course and award of certificates to the candidates.
7. There will be a test after completion of training and certificates will be issued only to the successful candidates.
8. Pass criteria shall be 60% in practical and 55% in written (Objective) examination. Written examination will be conducted in online/offline mode.
9. The training will be provided only during the day time & it is free cost training. No Boarding / Lodging facilities available. It should be borne by the candidates themselves.
10. Trainees should follow the rules of the organization with full safety of jobs, tools, gauges, Machines, Equipments, human etc. He/ she should not indulge in any activity which jeopardizes his /her safety or that of fellow workers. Further, he/she should not be part of any unethical activity. No FIR should have been lodged against the candidates.
11. Shortlisted candidates should submit an affidavit on Rs.10 non-judicial stamp paper, duly notarized to Railway for following the norms of skill development training. The affidavit should cover the issue on employment, discipline and safety etc.
12. The trainees will be provided safety equipment helmet, face shield, industrial boots, hand gloves etc. by the Training Centres required for developing the skill/ safety on returnable basis.
13. Trainees will not damage the Railway property during this training programme.
14. No allowance like daily allowance/conveyance allowance or travelling allowance etc will be paid to the trainee.
15. Successful candidates will be awarded certificate for undergoing skill development Training in the allotted trade by the respective Training Centres.
16. All Candidates must follow appropriate COVID-19 precautionary behaviour at all times.
