The engagement is subject to the following eligibility requirements & conditions:

1	Educational Qualification	1.BHMS doctor with internship 2.DHMS doctor Should have at least 1 ½ (One & half years) working experience (the difference in time period between DHMS and BHMS including internship in the later)
2	Age limit for consultant	should not be beyond 70 years of age as on date of notification
3	Period of the Engagement	For a term not exceeding one year (purely on contractual basis)
4	Honorarium	₹22,500 per month (Twenty two thousand & five hundred)
5	Working hours of Dispensary	Four hours (09.30 hrs to 13.30 hrs)

The application that is in the prescribed format along with attested copies of necessary certificates may be sent by ordinary post to "Assistant Personnel Officer, Signal & Telecommunication Workshop, Southern Railway, Podanur, Coimbatore-District, Tamil Nadu - 641 023" so as to reach on or before 16.9.2022. The Administration is not responsible for any postal delay and belated applications will not be entertained under any circumstance. The Candidates must furnish all the relevant information required. Furnishing of false and/or incomplete information shall lead to rejection of the application.

Mode of Engagement: Assessment of Suitability and Interview by the framed Committee.

It is to be informed that the engagement of the Homeopathic Consultant, on contract basis, is done by the Staff Benefit fund committee under the aegis of Central Staff Benefit Fund Committee and not by the Railways.
