NOTIFICATION FOR FILLING UP THE VACANCIES OF TEACHING CATEGORY IN SOUTHERN RAILWAY HIGHER SECONDARY SCHOOL, MADURAI ON CONTRACT BASIS

Applications are invited from candidates fulfilling the educational qualifications and other conditions to fill up the vacancies of teaching staff for the Academic session 2022-2023. The appointment will be for a period of not more than 200 (two hundred) working days and not less than 7 (seven) working days or appointment of a selected candidate through the Railway Recruitment Board or filling-up the vacancy through the promotion of existing regular teaching staff whichever is earlier and subject to any other instruction issued from time to time. The appointment is purely on a contract basis on a fixed consolidated monthly remuneration. The details of vacancies for contract appointment are as follows.

Age Limit: - The candidate should be between the age of **18 and 65 years** as on the date of the interview and the selected candidate shall not be eligible to continue their contract services beyond 65 years.

Essential Qualifications

1. Two years Integrated Post Graduate M.Sc/M.A Course of 'Regional College of Education of NCERT' in the concerned subject;

OR

Master's Degree from a **recognized University** with **at least 50% marks** in aggregate in the following subjects:

PGT (Biology) – Botany/Zoology/ Life Sciences/Bio Sciences/ Genetics/ Micro Biology/ Bio-Technology/Molecular Bio/Plant Physiology provided they have studied Botany and Zoology at the Graduation level.

PGT (English) - English

2. B.Ed. or equivalent degree from a recognized university.
3. Proficiency in teaching in English medium.

Desirable: Knowledge of computer applications.

Other terms and conditions:

1. The Contract teachers should perform all the jobs related to academics including evaluation work for which no extra payment will be made.
2. Contract teachers will have no claim or right for appointment on regular basis and will not form part of the cadre of regular Railway teachers, also they are not entitled for any other facilities of regular employees.
3. If the candidates are already in employment, they should produce no objection certificate from their current employer.
4. Original certificates in support of educational/Technical qualification and proof for age are to be produced by the candidates at the time of registration/ interview.

5. The contract teachers shall not have any right or claim for continuity in service or extension of contract period or regularization of service.
6. No TA/DA is admissible for attending the interview.
7. In the event of any wrong information/fake certificates/testimonials/discrepancy in the particulars being detected at any stage, the candidature/contract may be terminated summarily without any notice and necessary action as per extant law will be taken against them.
8. The selected candidates will have to execute an agreement with Railway administration for their contractual appointment.
9. The contract teachers are entitled for monthly consolidated remuneration and are not entitled to any other perks/facilities. In case of absence from duty on working days, pro rata recovery shall be made.
10. Contract teachers are not entitled for vacation pay and for vacation period the remuneration payable is on a pro-rata basis only.
11. Candidates should have requisite academic qualifications on the date of the Interview. Those who are appearing at and/or awaiting the results of the final examination are not eligible. Academic and Technical Qualification must be from a recognized Institution / Board, otherwise, the candidature will be rejected. Engagement on a Contract basis of the candidates will be subject to their being found suitable and in order of merit by the Selection Committee
12. The contract teachers appointed for a period of less than a month will be paid on a pro-rata basis only.
13. The calculation of pro rata remuneration will be as follows;
$$\frac{\text{(Consolidated monthly remuneration x Number of days worked)}}{30}$$
14. The decision of this office in all matters relating to eligibility, acceptance or rejection of the applications, selection, and allotment of posts to selected candidates will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection.
15. Separate applications should be submitted for each category if applying for more than one post.
16. Candidates called for interview must bring the following original documents along with two copies of the documents at the time of the interview.

1. Date of birth certificate.

2. NOC from the current Employer, if employed.

3. Teaching Experience Certificate

4. Academic/Educational Qualification of a recognized Institution/Board. (Mark Sheet, Degree Certificate/passing certificate etc.)

6. Aadhaar card and PAN card.

7. Duly filled application form in the prescribed format along with self-attested copies of all Certificate/documents with a passport-size photograph.

Interested candidates are advised to submit their application in the given prescribed format by e-mail to rhssmdu2020@gmail.com latest by **20/12/2022** and the name of the post applied should be shown in the subject field. Eligible candidates will be shortlisted and called for personal interview on short notice and the list of candidates with the date of the interview will be intimated through mail id to the candidates. Applications not in the prescribed format, applications without copies of required documents, and only CV/Resume shall be summarily rejected.
