Your RTI application cited under reference has been examined.

At the outset it is informed that the first three queries do not come under the purview of RTI Act 2005. As you may be aware, you can only seek information on the Government's action, decision etc. held in any electronic form, on paying additional fee of Rs.2/- per page and that the Public Authority is not supposed to create information. Only such information that is already existing with the public authority can only be furnished.

With regard to your query No.4 & 5, the following information is furnished:
