Office Order No.SA/55/2017/Elecl./Running

Sub:- Voluntary Retirement of Shri.S. Sivakumar, LP/Pass (SNP) /CBE

In terms of Rly. Bd. Letter No.E(P&A)II-2004/RS-05 RBE No.137/2016 dtd. 29.11.2016, whenever a medically decategorised running staff governed by RS(PR)1993, who has rendered the prescribed qualifying service, opts for Voluntary Retirement either on his own or within a period of one month from the date of offer of the first alternative post his pension may be computed with addition of 55% Pay Element. This 55% benefit will be reckoned after deducting the 30% Pay Element fixation benefit if granted already as per Board's letter dated 05.10.2011.

As all the conditions stated in Rly. Bd. Letter RBE No.137/2016 dtd. 29.11.2016, are satisfied, his request for Voluntary Retirement on his own dtd. 01.02.2017 & 23.03.2017 after medical decategorisation from the post of Loco Pilot/Pass (SNP)/CBE (Reference DPO/SA O.O No.SA/34/2017/Elecl./Running dtd.16.03.2017), is accepted by the competent authority and his services are terminated w.e.f. 02.05.2017.

His pension may be computed with addition of 55% of Pay Element.

He should return his Photo Identity Card, Medical Identity Card and all his Railway materials if any entrusted to him to CRC/CBE.

He should vacate Railway Quarters if in occupation by him as per extent orders. Retention of Railway Quarters beyond the permitted period will be treated as unauthorized occupation and the following course of action will be taken against him.

1. Cancellation of allotment and eviction proceeding
2. Recovery of damage rate of rent as per rules
3. Withholding of Post Retirement passes at the rate of one set for every month of unauthorized occupation for more than Ten days will be taken as a full month
4. The entire amount of DCRG will be withheld for non-vacation of Railway Quarters beyond the date of Voluntary Retirement

He will not be permitted to withdraw his request for Voluntary Retirement under any circumstances at a later date.

He will please obtain the Pension Forms from Ch.OS/Settlement/PB/SA and submit the same duly filled up in all respects, for arranging settlement dues.

The Qualifying service of the employee is 37 years, 10 months and 11 days and it has been certified by Sr.DFM/SA letter No.P.500/Sr.DFM/SA/PEN/Correspondence dated 11.04.2017.
