1. He is free from DAR/SPE/Vigilance Cases.
2. It will not confer on him any seniority benefits. His name will be continued to be maintained in the original seniority list of regular capacity and he will be considered for promotion on regular basis in the normal channel only.
3. He shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the Pay drawn by the employee such as HBA allotment of Railway accommodation shall be permitted.


