As per extant rules, his family is eligible for retention of Railway Quarters for 24 months on normal rent. If the family desires retention of Quarters, it should apply to DPO/SA immediately.

In case, if his family members are in occupation of Railway quarters beyond the period for which permission is granted, it will be treated as unauthorised and will result in the following course of action.

1. Cancellation of allotment
2. Eviction proceedings
3. Recovery of damage rate of rent
4. Withholding of payment of Death gratuity.
5. Forfeiture of one set of post retirement complementary pass for every month or part thereof unauthorised occupation of Railway Quarters.
