The following candidates have been appointed through Sports Quota under Talent Scouting Scheme for the year 2019-2020 to the post of Commercial-Cum-Ticket Clerk in Level-3 of pay Matrix vide reference cited above temporarily till nomination for Pro-CCTC initial training at MDZTI/TPJ in terms of Rly Bd's letter No. 2016/E(Sports)/4(1)/7/Training dt. 20.09.2016 (RBE. No.111/2016).

They have been directed for initial training online course from 16.09.2020 to 28.10.2020 and offline course at MDZTI/TPJ from 02.11.2020 to 07.12.2020 under batch No.2021082 and failed in the training course.

They have been directed for repeat training online course from 04.01.2021 to 13.02.2021 and offline course at MDZTI/TPJ from 15.02.2021 to 05.03.2021 under batch No.2021114 and line training from 06.03.21 to 17.03.2021 without stipend. After having successful completion of the prescribed training course they are now absorbed as Commercial-Cum-Ticket Clerk on Pay Rs.21700 in Pay Level-3 of Pay Matrix and posted to the stations mentioned against their names to work under the control of Supervisory concerned.

In terms of RBE No.23/95, the period of interruption between initial training period and repeat course (ie. from 08.12.2021 to till date) is treated as dies-non.
