- 3) SI No.03, 09, 10 & 12 were selected to the post of Small Track Machine/Helper, subject to their willingness to work as Artisan Helper in Pay Level-01 of Pay Matrix (GP Rs.1800/- VI CPC), though they had been promoted in the higher Grade Track Maintainer Gr.III in Pay Level -02 of Pay Matrix (GP Rs.1800/- VI CPC) in Engineering Department.
- 4) Action may be taken to relieve the employees in time, where ever transfer is involved.
- 5) The employees who are under orders of transfer to other station should vacate Rly Quarters immediately before being relieved if they wish to retain quarters, as stations Retention of quarters without/beyond permission will attract deduction of damaged rate of rent.
- 6) The employees who are transfer other station on administrative ground are eligible for all privileges on transfer account.
- 7) They are free from DAR/SPE Vig. clearance.

8) The date of joining at the new station by the employees should be advised to all concerned without fail.
