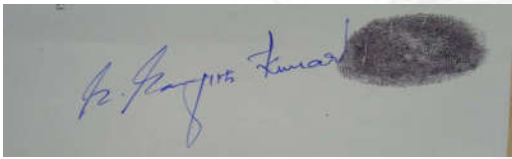
He is temporary utilized to IT/Cell/Sr.DPO/O/SA under the control of Ch.OS/IT/Cell/SA of Personnel Department.
