

On successful completion of the training, she will be absorbed in working post in level 6 of Pay Matrix as Probationary Station Master (Erstwhile Probationary ASM).

Her appointment as Pro. SM (Erstwhile Pro. ASM) is subject to the following conditions: -

01. Her pay as Station Master (Erstwhile ASM) at Rs.35400/-in level 6 of 7<sup>th</sup> CPC Pay Matrix will be fixed from the date of assuming duty in the regular working post as SM (Erstwhile ASM).
02. She will be on probation for a period of two years from the date of assuming duty in the regular working post as Station Master (Erstwhile Assistant Station Master) and her confirmation will be subject to her satisfactory performance during the period of probation. If found un-satisfactory during the probationary period, her services are liable to be terminated on one-month notice period in terms of IREM Vol.I Chapter XV.
03. Candidates who joined Railways after 01.01.2004 will be governed by new restructured defined contribution Pension Scheme introduced by Railway Board vide letter No. F(E) III/2003/PNI/24 dated 31.12.2003 (RBE No. 225/2003).
04. She will be responsible for the Government Money, Goods, Stores and other properties that may be entrusted to her in the discharge of her official duties.
05. Inter Railway one-way transfer / Inter Divisional one-way transfer will not be permitted prior to completion of 05 years / 03 years of service respectively in her regular working post, after training. i.e., training period will be excluded while computing the five years / three years period.
06. She should be prepared to serve anywhere on the Railway system. In all matters, not specifically provided herein or in the recruitment rules, she will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
07. Seniority will be assigned as per Indian Railway Establishment Manuel Vol. I. Chapter III in para 303 (a) and para 304.
