1. Shri.Manivannan.A, CCC/MTDM, EMP.No.15605468723 and Smt.Suhara.A, CCC/ED/GS, EMP.No.15605607358 promoted as Commercial Supervisor in PML-7(GP 4600) in VII PC Pay Matrix vide O.O. quoted above have expressed their unwillingness vide letter dt.03.02.2021 and dt.04.02.2021 respectively for Promotion to the post of Commercial Supervisor in PML-7(GP 4600) in VII PC Pay Matrix.

Consequently, they are debarred for further promotion for a period of one year from the date of issue of promotion order i.e. 01.02.2021.

As per IREM 224/II, they will not have claim over the seniority to their juniors who are promoted as Commercial Supervisor during the debarment period.

The above promotions are ordered subjected to the following conditions:

- There are no DAR/SPE/Vig cases pending /contemplated against them and that they are not undergoing any penalty debarring them from promotion. If anyone is undergoing any penalty, they will be deemed to be carrying out their current duties only till they become free from punishment.
- The promotees will be on probation for a period of 12 months from the date of shouldering higher responsibility.
- Monetary benefit on promotion will take effect from the date of shouldering higher responsibility.
- Staffs those who are transferred to other stations on promotions are eligible for all transfer benefits.
- The employees should carry out their promotion/transfer within 10 days from the date of issue of this order as stipulated in PBC No.114/199, otherwise, the concerned supervisors will be held responsible for not relieving them in time to carry out their promotion/transfer. If the employee is not willing to be promoted within the period specified above, the same will be treated as refusal of promotion as contained in Para 224 of IREM and they will not be eligible to be considered for promotion before the expiry of one year from the date of issue of this order and he will lose place to all juniors who will be promoted in the meanwhile.
- Their pay on promotion shall be fixed in the revised pay structure in terms of Rule 13 of RS (RP) Rules 2016 and next increment shall accrue on the 1st of July 2020 and thereafter it shall accrue after one year on annual basis in terms of Rule 10 of RS(RP) Rules 2016 issued under Railway Boards Letter No. PC-VII/2016/RSRP/1 dt.28.07.2016 (RBE

No.90/2016). They may exercise option within one month from the date of promotion to fix their pay either from the date of promotion or from the date of next increment under Rule 1313 (FR22) I (a) 1 of R.II in terms of RBE 79/2017.

g) In case of employees do not exercise any option within the stipulated period it may be noted that their pay will be fixed straight away from the date of promotion as envisaged under Rule 1313 (FR 22) I (a) 1 of R.II and no further option/revision is permissible. There are no pay fixation benefits for the employees who have already been granted the Financial up gradation under MACP scheme.

h) Any wrongful promotion/excess payment detected subsequently will be subject to rectification and recovery in terms of CPO/MAS letter No. P(S) 353/Court/Policy/ Vol. II dated 17.10.2017 (PBC No.184/2017).

i) The above promotions are provisional and subject to the outcome of the pending SLP's (C) No.30621/2011, 31288/2017 and 28306/2017 – filed before the Hon'ble Supreme Court communicated through RBE No.91/2018 dated 19.06.2018 & PBC No.116/2018 dated 25.06.2018.

Except those who are posted at the same station, all others have to vacate the railway quarters, if any, occupied by them immediately. If they wish to retain the quarters as per extant rules, they have to apply to Sr.DPO/SA for retention of quarters in the old station. Retention of quarters without permission/ beyond permission will attract deduction of penal rent.

The date of relief/joining may please be advised to all concerned and to this office.
