The under mentioned candidates, who have been selected through RRB for appointment to the post of Assistant Loco Pilot in Level 2 of Pay Matrix, on having accepted the offer of appointment and on being found Medically fit in class AYE ONE were sent for initial training. On completion of initial training successfully they are absorbed as Assistant Loco Pilot in level 2 of pay matrix against the working post and posted to the station noted against each. Their pay is fixed at Rs. 19900 in Level 2 on notional basis from the date of joining for counting the training period for the purpose of granting increments and they are eligible for draw pay on actual basis in Level 2 from the date of regular absorption.

- 2 They are eligible to claim pay in Level 2 of pay matrix only from the date of absorption in the working post.
- 3 The intervening period from the date of completion of training and the actual absorption to the working post is treated as extension of training in terms of Rly Board's letter No. E(NG)II/57/AK/1/4 Dt 17.01.1969.
- 4 The above absorption against the working post is subject to the conditions stipulated in this office offer of Appointment issued to them at the time of their Appointment as Trainee Assistant Loco Pilot

- 8 Their seniority will be assigned in due course.
- 9 Their absorption as Assistant Loco Pilot is purely provisional subject to the receipt of verification report from civil/police authorities regarding their character and antecedents. If anything adverse in the said report is found regarding their suitability for appointment, their services are liable to be terminated forthwith without any notice.
