Sub: Appointment of candidate as Trainee Technician Gr.III/C&W in Gr.C Services through CGA – Mechanical C&W Department.

Ref: 1. Offer of appointment issued under this office letter No.SA/P.269/IV/CGA dt 08.07.2021

The under mentioned candidate has been considered for appointment in Group-'C' Services through CGA as Tr.Technician Gr.III/C&W in Mechanical-C&W Department in Pay Matrix Level 02 vide reference -1 . Having accepted the offer of appointment issued vide this office letter No. No.SA/P.2269/IV/CGA dt 08.07.2021 on the terms and conditions for such appointment, he is appointed as Trainee Technician Gr.III/C&W in Mechanical-C&W Department, Salem Division on stipend Rs.19900 in Pay Matrix Level 02 in VII CPC plus other allowances admissible under Rules from time to time. He has to undergo 26 weeks training from the date he joins duty. He is assigned to SSE/C&W/CBE for training. The training schedule will follow from Sr.DME/O/SA. The final place of posting will be done after the successful completion of the training.

The appointment of the above named candidate is subject to the following terms and conditions:

1. He should undergo prescribed training for a period of 06 months from the date he joins duty.
2. He must clearly understand that the appointment is terminable on 14 days notice on either side, except that no such notice is required if the termination of service is due to the expiry of sanction to the post he holds or on return duty of the absentee in whose place he may be engaged, in which case his service will automatically terminate from the date of expiry of the sanction or from the date the former resumes duty, as the case may be, also no such notice will be required if the termination of service is due to his mental or physical incapacity or to his removal or dismissal as a disciplinary measure after compliance with the provisions of clause (2) of Article 311 of the constitution of India.
3. On successful completion of training, he will be absorbed as Technician Gr.III/C&W in Mech-C&W Department in Pay Matrix Level 02 in VII CPC plus usual allowances admissible under the Rules in force from time to time.
4. He will be placed on probation for a period of two years from the date of his absorption and his continuance beyond the probationary period is subject to review at the end of that period.
5. He should adhere to the terms and conditions of the agreement and also the indemnity bond in which he has entered.

---- continued the subject to the following terms and conditions:

6. On completion of training, he will serve the Railway administration for a minimum period of five years.
7. He will not be allowed to withdraw from training except for reasons, which are beyond his control.
8. In case he fails to serve the administration for a minimum period of 5 years as stated above, or wish to withdraw from training for any reasons which are not beyond his control or withdraw willfully by absenting himself or adopting any other unfair tactics he will be liable to refundable whole cost of his training as well as any other money paid to him during the

period of training by the way of stipend/pay etc. The cost of training, being understood to be 12.5% of the pay and allowance excluding traveling and running allowance that has been drawn by him.

9. He will not be considered for Inter Divisional Transfer and Inter Railway Transfer before completion of required period of regular service in the working post.

10. His continuance in service is subject to his qualifying in the duties prescribed for the post he holds and the qualifying of such other general conditions of service as may be laid down from time to time.

11. He will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to him.

12. He must be prepared to serve any where on the Southern Railway System.

13. He is liable for service in the Railway Engineering unit of the Territorial Army for such period as may be laid down on this from time to time.

14. He will confirm to all the Rules and Regulations applicable to his appointment.

15. He required serving in field allied or different from the one he is appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be altered covering different skills and fields in which he should be ready to serve, refusal to perform duty in this manner will make him liable for terminate of service.

16. . The appointing authority however reserves the right of terminating their services forth with or before the expiry of the stipulated period of notice by making payment to him of the sum equivalent to pay and allowances for the period of notice or the un-expired portion thereof. He should not resign or quit his employment except with the previous consent in writing to the Head of the department or office in which he is employed.

17. He is covered by the New Pension Scheme as per Railway Board letter dt.13.12.04 communicated under PBC NO. 22/2004.

18. The appointment is provisional and subject to verification of character and antecedents and in the case of any adverse report received later on the services will be terminated.

19. In all other matters not specifically provided hereon or on the Recruitment Rules, he will be governed by Indian railway establishment code and other extant orders issued and amended from time to time.

20. The terms and condition stipulated in the offer of appointment stand good.
