01. The seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Volume 1.
  02. His pay will be fixed from the date of assuming independent duty as Goods Guard at the place of posting.
  03. He will be on probation for a period of two (2) years from the date of taken independent duty against the regular working post as Goods Guard and his confirmation will be subject to his satisfactory performance during the period of probation.
  04. Candidates who join Railways after 01.01.2004 will be governed by new restructured defined contributory pension scheme introduced by Railway Board vide letter No. F(E) III/2003/PNI dated 31.12.2003 (RBE No. 225/2003).
  05. He will be responsible for the government Money, Goods, Stores and other properties that may be entrusted to him in the discharge of his official duties.
  06. No request for Inter Divisional / Inter Railway one-way transfer will be registered prior to completion of three years of service on the regular working post i.e., after training in terms of PBC No. 60/2018 circulated by PCPO/MAS vide letter No. P(R) 676/P/Vol. VI dated 09.04.2018 and PBC 215/2018 dated 24.10.2018. He should be prepared to serve anywhere on the Railway system.
  07. The intervening period between the date of completion of training and the actual date of absorption is treated as extension of training in terms of Rly. Board's letter No. E(NG)II56/AK/1/4 dated 17.01.69.
  08. In all matters, not specifically provided herein or in the recruitment rules, he will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
- The date of joining of the employee against the working post may be advised to all concerned.
