1. On successful completion of the training period they will be absorbed against working posts as Technician Gr.III.
2. They have executed necessary agreement for apprenticeship.
3. They will not be allowed to withdraw from training except for reason which are considered by the administration as beyond their control.
4. On successful completion of the training they have to serve the Railway administration for a minimum period of Five years. If they fail to serve the Railway administration for Five years or willfully withdraw training, they are liable to refund the whole cost of training and any other money paid to them during the training period. The cost of training is worked out to be 12 ½ % of pay and allowances including travelling allowances.
5. They are governed by the newly defined contributory pension system.
6. The above rank is provisional & their rank/seniority will be based on the final select list published by Railway Recruitment Board/MAS
