He is further informed that in case he is in occupation of Railway Qrs. beyond the period for which permission is granted on the application submitted by him it will be treated as unauthorized and will result in forfeiture of one set of post retirement pass on every one month of unauthorized retention of Rly. Qtrs. in terms of Railway Board's letter No.E(G)81/Qtrs./5 dt.04.06.1994.

He shall open necessary account for drawal of pension and other benefits in any nationalized banks, Post offices or Govt. Treasuries. He should also obtain settlement forms and hand over the same duly filled in within a fortnight from the date of issue of the O.O.
