It is proposed to fill up the above vacancies by conducting selection. Therefore,  
Volunteers are called for from the following erstwhile Group D employees of Medical  
Department SA Division who are fulfilling the eligibility conditions:

1. Hospital Attendant in L-1 of Pay Matrix
2. House Keeping Assistant in L-1 of Pay Matrix

Eligibility conditions:

1. The volunteers having minimum educational qualification of 10<sup>th</sup> Std/  
Matriculation pass
2. 3 years regular service on the date of issue of this Notification.

Mode of Selection:

The selection will be on the basis of the written examination only and assessment of  
Record of service. As per the instructions contained in Railway Board's letter No.  
E(NG)I-2003/CPF/2 dt. 22.09.2003 (RBE 164/2003), there will be no viva-voce and  
the selection will be based on the written examination and scrutinising of Record of  
service.

The question paper will be 100% objective type. All the questions will be multiple  
choices only. The exam will be conducted in Computer Based Test or pen and paper  
mode. To ensure the authenticity of the answers, cutting, overwriting, erasing or  
alternation of any type in the answer will not be accepted. Zero marks will be given  
for answer having correction/over writing. There shall be negative marking for  
incorrect answers. **One third of the marks allotted for each question will be  
deducted for wrong answers** and the 10% of the total marks will be from Official  
Language Policy and rules as per Railway Board Lr. No. E(NG) 1/2018/pm1/4  
dt.14.11.2019(RBE No. 194/2019) circulated vide PCPO/MAS Lr. No.  
P(R)608/P/Vo;.III dt. 14.11.2019 (PBC 264/2019). The questions on official language  
policy and rules may not be compulsory.

The exact date, time and venue of the written examination will be notified in due course.

In the event of an employee being selected, he/she may be posted to any one of the Hospitals in Salem Division subject to requirement. Applicants not agreeing to this may kindly be advised not to apply for the selection.

Syllabus for the selection is enclosed as Annexure- I.

The employees may be advised that the eligible list of employees for the written examination will be alerted after scrutiny of the applications.

This Notification is to be given wide publicity and employees who are on leave/sick list etc., should also be notified of the Selection.

Those staff who are willing may submit their application through their supervisory officials in the prescribed pro-forma enclosed as Annexure-II along with the attested copy of the certificates in proof of their educational qualification, community etc., The supervisory officials should collect the applications and the same should be forwarded with a covering letter in one bunch to reach this office on or before 13.09.2021 duly certified. Applications received after the target date will not be considered under any circumstances.

Respective Supervisors are requested to collect the applications from volunteers and forward the same to this office in one bunch on or before 13.09.2021.

If No application is received from the employees, a NIL report should be submitted by the respective Supervisor.
