2	Age limit for consultant	Should not be beyond 65 years of age as on date of notification.
3	Honorarium	Rs.22,500/- per month (Twenty Two thousand and Five hundred per month)
4	Period of engagement	For a term not exceeding one year (Purely on contractual basis)
5	Working hours of dispensary	Four hours daily except on Sundays (08.00 hrs to 12.00 hrs)

It is to be informed that the engagement of the Homeopathic Consultant on contract basis is done by the Staff Benefit fund Committee under the aegis of Central Staff Benefit Fund Committee and not by the Railways.
