The above promotion is ordered subjected to the following conditions:

- There are no DAR/SPE/Vig. cases pending /contemplated against her and that she is not undergoing any penalty debarring her from promotion. If anyone is undergoing any penalty, she will be deemed to be carrying out her current duties only till she become free from punishment.
- The promotee will be on probation for a period of 12 months from the date of shouldering higher responsibility.
- Monetary benefit on promotion will take effect from the date of shouldering higher responsibility.
- She is eligible for all transfer benefits.
- The employee should carry out her promotion/transfer within 10 days from the date of issue of this order as stipulated in PBC No.114/199, otherwise, the concerned supervisors will be held responsible for not relieving her in time to carry out her promotion/transfer. If the employee is not willing to be promoted within the period specified above, the same will be treated as refusal of promotion as contained in Para 224 of IREM and she will not be eligible to be considered for promotion before the expiry of one year from the date of issue of this order and she will lose place to all juniors who will be promoted in the meanwhile.
- Her pay on promotion shall be fixed in the revised pay structure in terms of Rule 13 of RS (RP) Rules 2016 and next increment shall accrue on the 1st of July 2022 and thereafter it shall accrue after one year on annual basis in terms of Rule 10 of RS(RP) Rules 2016 issued under Railway Boards letter No. PC-VII/2016/RSRP/1 dt.28.07.2016 (RBE No.90/2016). She may exercise option within one month from the date of promotion to fix her pay either from the date of promotion or from the date of next increment under Rule 1313 (FR22) I (a) 1 of R.II in terms of RBE 79/2017.
- In case of employees do not exercise any option within the stipulated period it may be noted that her pay will be fixed

straight away from the date of promotion as envisaged under Rule 1313 (FR 22) I (a) 1 of R.II and no further option/revision is permissible. There are no pay fixation benefits for the employees who have already been granted the Financial up gradation under MACP scheme.

h) Any wrongful promotion/excess payment detected subsequently will be subject to rectification and recovery in terms of CPO/MAS letter No. P(S) 353/Court/Policy/ Vol. II dated 17.10.2017 (PBC No.184/2017).

i) The above promotion is provisional and subject to the outcome of the pending SLP's (C) No.30621/2011, 31288/2017 and 28306/2017 – filed before the Hon'ble Supreme Court communicated through RBE No.91/2018 dated 19.06.2018 & PBC No.116/2018 dated 25.06.2018.

She has to vacate the railway quarters, if any, occupied by her immediately. If she wishes to retain the quarters as per extant rules, she has to apply to DPO/SA for retention of quarters in the old station. Retention of quarters without permission/ beyond permission will attract deduction of penal rent.
