



The above transfer is agreed subject to the following conditions:-

1. The employees will take the seniority in the new seniority unit to which they are transferred as per extant orders applicable to Inter Railway Mutual transfer (ie) they will either retain their own seniority or take the seniority of the other in the new seniority unit to which they are posted, whichever is lower.
2. They will not seek re-transfer to their parent Unit/Railway at a later date
3. They are not eligible for any transfer benefits on transfer account as the transfers are agreed at their own request
4. They will retain their lien in the Parent Departments seniority unit until they are permanently absorbed in the new seniority unit to which they are posted.
5. They should be free from DAR/SPE/Vig cases as on date of their relief.
6. They may vacate quarters, if, any occupied by them. If they wish to retain the quarters as per extant rules, they have to

apply to Sr.DPO/SA for retention of quarters in the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.

7. In terms of Railway Board's letter No.E(NG)-1/2006/TR/6 dated 21.04.2006 (RBE No: 53/2006), no request for back tracking from the above employees from the mutual exchange to be entertained in any circumstances.

8. Shri Manju Kumar Asst/C&W/ED/SA Division may be relieved with proper identification Memo and attested passport size photograph, signature and thumb impression to report to Sr.DPO/SA in terms of instructions contained in Railway Board's letter No.E(NG)1-2001/TR-16 Dated 21.11.2001.

9. The employees may be relieved in terms of instructions contained in Railway Board's letter No.E(NG)1-2007/TR/26 Dated 04.12.2007.
