3. He shall open necessary bank account for drawl of pension and other benefits. He should also obtain settlement forms

and hand over the same duly filled in
within a fortnight from the date of issue of O.O.

4. He shall not apply for commutation of a part of his pension prior to expiry of the period of 3 months notice period as per Rule 67 (3) (b) of Railway services (Pension) Rules 1993 .
