His appointment as Commercial-Cum-Ticket-Clerk is subject to the following conditions: -

1. He will be on probation for a period of TWO YEARS from the date of reporting to the regular working post as CCTC and his confirmation will be subject to his satisfactory performance during the period of probation.
2. Those who joined Railways after 01.01.2004 will be governed by new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E) III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).
3. He will be responsible for the government Money, Goods, Stored and other properties that may be entrusted to him in the discharge of his official duties.
4. He should be prepared to serve anywhere on the Railway system.
5. In all matters, not specifically provided herein or in the recruitment rules, he will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
6. Seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Vol-I.
7. He has executed the Service Bond and accepted the offer of Appointment as prescribed vide Rly Bd's letter No. 20110/E(Sports)/4(1)/1(Policy) dt.31.12.2010 (RBE No.189/2010)
8. He must clearly understand that, his employment under government is temporary and his services may be terminated at any time without notice if such termination is due to expiry of the officiating vacancy in which he may be appointed or due to his removal or dismissal as a disciplinary measure after compliance with the provision of Article 311 of the constitution of India; otherwise the appointment may be terminated at any time by 14 days' notice given by either side without any reason being assigned
9. The appointing authority, however reserve the right of terminating his service forthwith or before the expiry of the stipulated period of notice by making payment to him of the sum equivalent to pay and allowance for the period of notice or the unexpired portion thereof. He should not resign or quit his employment except with the previous consent in writing of the Head of the department or office in which he is employed.
10. Appointment of above candidate is purely provisional and subject to the receipt of verification report form Civil/police authorities regarding his character and antecedents.
11. The appointment is provisional and is subject to the community certificate being verified through the proper channels. If the verification reveals that the claim of the candidate to belong to other Backward Classes/Schedule Caste/Schedule

Tribe or not to belong to creamy layer is false, his service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false certificate.
