The appointment is subject to the following terms and conditions:-

1. Her pay will be drawn from the date of assuming independent duty as Station Master at the place of posting.
2. She will be on probation for a period of TWO YEARS from the date of reporting to the regular working post as Station Master (Unified Cadre) and her confirmation will be subject to her satisfactory performance during the period of probation.
3. Candidate who joined Railways after 01.01.2004 will be governed by new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E) III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).
4. The intervening period between the date of completion of training and the actual date of absorption is treated as an extension of training in terms of Rly.Board's Lr.No.E(NG) II/56/AK/1/4 dt.17.01.1969.
5. No request transfer for Inter Divisional/Inter Railway One-way transfer will be registered prior to the completion of three years of service on the regular working post i.e., after training in terms of PBC No. 60/2018 circulated by PCPO/MAS vide Lr.No.P(R)/676/P.Vol.VI dtd.09.04.2018.
6. She will be responsible for the government Money, Goods, Stored and other properties that may be entrusted to them in the discharge of their official duties.
7. She should be prepared to serve anywhere on the Railway system.
8. In all matters, not specifically provided herein or in the recruitment's rules, she will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
9. Seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Vol-I.
10. The employees who are appointed against CGA are required to maintain properly the other family members who have been dependant on his/her father and in case it is proved subsequently that the family members are being neglected or are not being properly maintained by them, their appointment will be terminated forthwith without following the procedure prescribed in the Disciplinary Rules/Temporary Railway rules for this purpose.
