The following Junior engineers in Level-6 who are placed on provisional select list published vide Memorandum No.SA/P.608/VII/SSE dt.14.09.2021 for promotion to the post of SSE Electrical Department are promoted as SSE/TRD in Level 7 of Pay Matrix and posted to the stations indicated against each against existing vacancies

The above promotion is ordered subject to the following conditions:

1. The employees will be on probation for a period of 12 months from the date of entry in the promoted grade. Continuance of promotee in the promoted grade will depend on his performance and successful completion of probation period as per para 113 of IREM & Railway Board's letter No. E(NG)1-98/CN5/1 dt. 02.08.2020 (RBE 148/2001 & PBC 135/2001). Non-completion of probation period is a failure on the part of promotee. In case, before the successful completion of probation period in the promoted grade, if the promotee seeks transfer to a post from which he was promoted, his pay in lower grade/post on such reversion will be fixed at a stage what he would have drawn had he not been promoted.
2. They are not placed under suspension and no department/criminal proceedings etc., are pending against his or he is not undergoing penalty debarring his for promotion.
3. Employees if posted to different stations are eligible for privileges on transfer account as they are transferred on administrative grounds.

If the employees are not willing to be promoted within the period of one month, from the dated of receipt of orders, the same will be treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year from the date of refusal and they will lose place to all juniors who will be promoted in the meanwhile.

5. The employees promoted above may exercise option for fixation of pay as per Railway Board's letter no. PC VII/2016/1/6/2 Dt. 31.07.2017 (RBE-79/2017) within one month of assuming higher responsibility under Rule 1313 RII 9FR-22(i) a I). In case, if they not exercise option within one month from the date of shouldering higher responsibilities their pay will be fixed straight away in terms of Rule 1313 R II (FR-22(1) (A) 1 and no further option/revision is permissible.

6. The above selection/Promotion has been initiated/ordered only after ascertaining quantifiable date of representation of SC and ST employees in the grade, as per the post-based rosters, against roster point mentioned against each. Accordingly, promotion orders are issued in compliance with the directions of the Hon'ble Supreme Court in M. Nagaraj case.

7. In terms of RBE 17/2016, the promotions are provisional and subject to the outcome of SLP(C) No. 4831/2012 filed by Hon'ble Supreme court of India.

8. As per Railway Board letter No.2018-E(SCT)1/25/9 dt 19.06.2018 circulated as PBC No:116/2018, the promotion is subject to further orders which may be passed by Hon'ble Supreme Court.

9. The Promotion ordered above is subject to outcome of cases filed various courts.

10. There is no pay fixation to the employees for whom pay fixation is already done consequent on financial up gradation under MACP scheme.

11. The actual date of assuming higher responsibility on promotion as Senior Section Engineer/TRD may be advised to all concerned.
