The senior employee Shri V. Udayasuriyan, ALS/DSL/E/ED, is undergoing a penalty of “ two stages reduction of pay in time scale of pay for the period of 36 months without the effect of postponing future increments ” and that this penalty runs up to 16.02.2023. Hence, this employee will not be considered for promotion to the post of Technician Gr. III.

The above Promotion is ordered subject to the following conditions:

1. They are free from DAR/SPE/Vigilance cases.
2. There is a probation period of 12 months in the promotion grade. At the end of the probation period, if the appointing authority considers that the work of the railway servant during the one year probation period on promotion has not been satisfactory, or the same is needed to be watched for some time, he may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation, as the case may be, as stipulated in Para.113 of IREM Vol. I.
3. They are not placed under suspension and no departmental/criminal proceedings etc., is pending against them or they are not undergoing any penalty debarring them from promotion, which should be ensured by the Supervisor before implementing the orders.
4. Any wrongful promotion /excess payment detected subsequently will be subject to rectification and recovery in terms of CPO/MAS letter No. P(S) 353/Court/ Policy/Vol. II dated 17.10.2017 (PBC No. 184/2017).
5. They may exercise option for fixation of pay as per Railway Board's letter No.PC VII/2016/1/6/2 Dt.31.07.2017(RBE 79/2017) (PBC 115/2017) within one month. In case they not exercise option within one month from the date of shouldering higher responsibilities their pay will be fixed straight away.
6. The above promotions are provisional and subject to the outcome of pending court cases/litigation.
7. The above promotion will take effect from assuming higher responsibility.
