The above up gradation is subject to all the terms and conditions as laid down in Board's letter cited, such as,

1. They are free from DAR/SPE/Vigilance cases pending/initiated/contemplated against them.
2. It will not confer on them any seniority benefits. Their name will be continued to be maintained in the original seniority list of regular capacity and they will be considered for promotion on regular basis in the normal channel only.
3. There shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by the employee such as HBA, allotment of Railway accommodation shall be permitted.
4. They may exercise option for the fixation of pay as under:
  - (a). either initial pay may be fixed in the higher post on the basis of Rule 1313 R.II (FR 22 (i) (a) (i) straightaway without any further review on accrual of increment in the pay scale of the lower post.  
OR
  - (b). Pay on promotion may be fixed initially at the stage on a time scale of the new post above the pay in the lower post, which may be re-fixed on the basis of the provision under Rule 1313 R.II (FR 22(1) (a) (i) on the date of accrual of next increment in the scale of the lower post.
5. In case the employees do not exercise any option within the stipulated period it may be noted that their pay will be fixed as under 4(a) above.
