Shri.P V S Gokulnath ALP/SA, Emp. No.242-29802006, was imposed with the penalty of removal from service w.e.f. 04.02.2021 vide Penalty advice No. SA/Ele-OP/ DAR/SF 05/2020-21/07 dtd. 04.02.2021 issued by Sr DEE/OP/SA and his services were terminated w.e.f. 04.02.2021 vide this office O.O. quoted above.

On appeal, ADRM has ordered vide letter dated 22.10.2021 to reinstate him in Railway Service passing of the following orders: -

"Considering his father's death and then he has an younger brother without parents. With the sympathetic consideration, the Removal from Service is reviewed, and I order to re-instate to the service duly revision of penalty from Removal from service to reduction to the lowest pay in Level (2) from his present pay duly reducing his pay to Rs.19900/- in Level-2 for a period of four years with effect of postponing future increments. The period from the date of Removal from Service to date of re-joining duty will be treated as dies-non"

He is reinstated as ALP and posted to SA under the control of CCRC/SA.

The date of joining duty may be advised to all concerned.
