The Promotions ordered above are subject to the following conditions:

1. The promotion order will take effect from the date of shouldering higher responsibilities.
2. The promotion of Sl.No.5 to 8 above are provisional subject to the verification of their community certificate.
3. That they are not placed under suspension and no DAR/SPE/Vigilance cases pending/ contemplated against them or they are not undergoing any penalty debarring them for promotion.
4. They are allowed to exercise option within a period of one month from the date of promotion under Rule 1313 (FR 22) (1) a(i) of R-II. In case the employees do not exercise any option within the stipulated period, it may be noted that their pay will be fixed as envisaged under Rule 1313(FR 22 of R-II) and no further option (Revision) is permissible.
5. They will be on probation for a period of one year from the date of promotion to higher grade under Rule 113 of Chapter-1 section F of IREM (1989 Edition). Their promotion are subject to review at the end of the probationary period and if found to be satisfactory they will be deemed to be confirmed in the higher promotional grade.
6. In case where financial upgradation under ACP/MACP scheme has already been granted and pay fixed accordingly, no further pay fixation will arise at the time of regular promotion.
7. The date of relief /joining of the above named employees may be advised to all concerned.
8. The cases of employees refusing promotion expressly or otherwise will be dealt under Rule 224 of IREM Vol.I (1989 Edition and Para-13 (i) of MCNo.31.
9. The above selection/promotion has been initiated/ordered subject to further orders which may be passed by the Hon'ble Supreme Court as per RBE. No.-91/2018 dated 12.06.2018 circulated under PBC No. 116/2018 dated 2506.2019.
