Voluntary Retirement once sought for by the employee and accepted by the Competent Authority is final. His request for re-appointment at a later date will not be entertained.

He should hand over all the Railway materials including the Medical Identity card to the controlling officer and should vacate Rly.Qrs if any in occupation. He is further informed that in case he is in occupation of Railway Qrs beyond the period for which permission is granted on the application submitted by him it will be treated as unauthorized and will result in forfeiture of one set of post retirement pass on every one month of unauthorized retention of Rly.Qrs in terms of Railway Board's letter No.E(G)81/Qrs/5 dt.04.06.1994.

He shall open necessary bank account for drawal of pension and other benefits. He should also obtain the settlement

forms and hand over the same duly filled in within a fortnight from the date of issue of the O.O.

The Qualifying service of Shri.C.Kaliyappan , is 37 years, 08 months and 24 days as on 21.07.2021 and it has been certified by Sr.DFM/SA vide letter No.P.500/Sr.DFM/SA/PEN/Correspondence Dt: 19.11.2021.
