The above inter Railway Mutual transfer is ordered subject to the following Conditions:-

1. As per Railway Board Letter No. E(NG)I-2018/TR/8 dated 26.10.2018 the above Mutual Transfer is ordered on reversion to the recruitment grade as Technician Gr.III in Pay Matrix Level-2 on bottom seniority.
2. They are free from DAR/SPE/Vigilance cases.
3. They will take seniority in the new seniority unit to which they are transferred as per extent orders applicable to request for Inter Railway mutual transfer.
4. As the transfer is ordered at their own request they are not eligible for transfer grant, joining time etc, on transfer account.
5. They will retain their lien in the parent department till they are permanently absorbed in the new seniority unit to which they are posted.

6. They will not seek re-transfer to their parent Railway/Division at a later date.

7. The relieving Memorandum/Order sparing the employee should have the photograph of the employee pasted on it duly attested in the manner viz. the rubber stamp should clearly indicate the name and designation of the Supervisory/Officer. The Memorandum/Order should also have the signature of the transferred employee and his left thumb impression both of which should be duly attested by the Officer signing the Memorandum/Order with his name and designation appearing below the signature as stipulated in Railway Board's letter No.E(NG)1-2001/TR-16 Dated.21.11.2001.

8. As per Railway Board's letter No. E (NG) 2006/TR/6 dated 21.04.2006 & 12.11.2009, no request for back tracking from the mutual exchange arrangement will be entertained under any circumstances. Strict adherence to this procedure has to be ensured.

9. As per RBE.No. 65/2018 dated 09.05.18, both the employees should be spared immediately within a week, without waiting for reliever.

10. They should vacate the Rly. Quarters if any under their occupation or to retain the quarters in the old stations they should apply to the competent authority as per the extant rules.

The date of relief/joining of the above employees may be advised to all concerned.
