The above mutual transfer is ordered subject to the conditions mentioned below:

1. They will be placed on bottom seniority in the new seniority unit to which they are transferred as per extant rule.
2. They will retain their lien in their parent unit until they are permanently absorbed in the new seniority unit to which they are transferred.
3. There should not be any DAR/SPE/Vigilance Cases pending/contemplated against them on the date of their relief.
4. They are not be eligible for any privileges on transfer account such as Joining time, TA, Transfer pass, Transfer grant etc., as the transfer is ordered at their own request.
5. They should vacate the Railway Quarters, if any, under their occupation and hand over the Railway material if any under their possession to their immediate Supervisor.
6. They will not seek re-transfer to their parent unit/Railway at a later date.
7. The employees are hereby advised that in terms of Railway Board's letter No.E(NG)I-2006/ TR/6 dt.21.04.06 & 12.11.2009, no request for backtracking from the mutual exchange arrangement will be entertained under any circumstances.

8. The employees may be relieved with proper Identification Memo and attested Passport size photograph, signature and thumb impression in terms of instructions contained in Rly. Bd's letter No.E(NG)I-2001/TR/16 dated. 21.11.2001 and letter No.E(NG)I-2007/TR/26 dated. 04.12.2007.

In terms of Rly Bd's letter No.E(NG)1-2017/TR/24 (RBE No.65/2018) dated:09.05.2018 All mutual transfer cases where NOC has been given by both the Railway/Units i.e. accepting and relieving, both the employees should be spared immediately within a week, without either unit waiting for the reliever.
