Sub: Appointment on compassionate Ground as Trainee Technician Gr.III (Blacksmith) in Pay Level-2 in Engineering Department.

Having accepted this office offer of appointment letter of even number dated: 09.08.2021, the under mentioned candidate who has been selected for appointment to Group 'C' service on compassionate Ground as Technician Gr.III, is appointed as Trainee Technician Grade-III (Blacksmith) in Pay Level-2 of 7th CPC Pay Matrix in Engineering Department and posted to SSE/P.Way/ED section under the control of SSE/P.Way/ED for training.

He has to undergo 6 months training during which he will be paid stipend at the rate of Rs. 19900/- (GP Rs.1900 in VIth PC) along with usual allowances admissible as per the extent rules from time to time.

The above Appointment is made subject to the following conditions:

1. He must clearly understand that the appointment is terminable on 14 days notice on either side, except that no such notice is required if the termination of service is due to the expiry of sanction to the post he holds or return to duty of the absentee in whose place he may be engaged, in which case the services will automatically terminate from the date of expiry of the sanction or from the date the former resumes duty, as the case may be. Also no such notice will required if the termination of service is due to his mental or physical incapacity or to his removal or dismissal as a disciplinary measure after compliance with the provisions of Clause (2) of Article 311 of the Constitution of India.
2. On successful completion of the training, he will be absorbed as Temporary Technician Gr.III in Pay Level -2 plus usual Allowances admissible under the Rules in force from time to time. He will be placed on probation for a period of 2 years from the date of absorption and his continuance beyond the probationary period is subject to review at the end of that period.
3. He should adhere the terms and conditions of the Agreement and also the Indemnity Bond in which he has entered.
4. On completion of training he will have to serve the Railway administration for a minimum period of five years if required by the Administration.
5. He will not be allowed to withdraw from training except for any reasons which are beyond his control.
6. Registration for Inter-Divisional/Inter-Railway transfer is to be sought for only after completion of required months of service from the date of regular absorption against working post.
7. In case he fails to serve the Administration for a minimum period of 5 years as stated above or wishes to Withdraw

from training for any reasons which are not beyond his control or withdraw willfully by absenting himself or adopting any other unfair tactics, he will be liable to refund the whole cost of training as well as any other money paid to him during the period of training by the way of stipend/pay etc., The cost of training being understood to be 12.5 % of the pay and allowances excluding Traveling and Running Allowances that will be drawn by him.

8. His continuance in services are subject to his qualifying in the duties prescribed for the post he holds and his qualifying of such other general conditions of service as may be laid down from time to time. He will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to him.

9. He must be prepared to serve anywhere on the Southern Railway system.

10. He is liable for service in the Railway Engineering Unit of the Territorial Army for a period of 12 years or for such period as may be laid down on this behalf from time to time.

11. He is eligible for Leave and Passes as per extant orders. He will conform to all the Rules and Regulations applicable to his appointment.

12. He is required to serve in fields allied or different from the one they are appointed and for this purpose necessary training will also be imparted. Till such time in exigencies of service, the requirement will also be altered covering different skills and field in which he should be ready to serve; refusal to perform duty in this manner will make them liable for termination of service.

13. He is required to maintain properly the other family members who have been dependent on him and in case it is proved subsequently that the family members are being neglected or are not being properly maintained by him, his appointment will be terminated forthwith without following the procedure prescribed in the Disciplinary Rules/Temporary railway Rules for this purpose.

Note: In all other matter not specifically provided hereon or on the recruitment rules, he will be governed by Indian Railway Establishment code and other extant orders issued and amended from time to time.
