Sub: Filling up of post of Assistant Loco Pilot in Level 2 (₹.19900-63200) against 50% Promotional Quota earmarked for Lateral Induction from maintenance staff of Diesel/Electric Loco - Electrical Operations Department

1. It is proposed to conduct a selection for the post of Assistant Loco Pilot in Level-2 (₹.19900-63200) against 50% PRQ earmarked for Lateral Induction from Maintenance staff of Diesel/Electrical Sheds in Electrical Operations Department of Salem Division, for the vacancies as detailed below: -

SC: 05 ST: 03 UR: 26 **Total: 34**

2. Volunteers as detailed below are called for to fill up the above vacancies

- (i) **Technician Grade III** in Diesel /Electric Loco Sheds having three years of service as Technician Grade III in the Diesel/Electric Loco Sheds having educational qualification of Matriculation or Matriculation with ITI as an additional preferable qualification. (As ITI in the relevant trade is an additional qualification, matriculates without ITI in relevant trade can also apply).
- (ii) **Technician Grade III** in Diesel /Electric Loco sheds having less than 3 years of service but total service of 6 years in Diesel /Electric Loco sheds, **Helpers** in Diesel /Electric Loco Sheds with a total service of 6 years in respective sheds having the qualification of course Completed Act Apprenticeship in the Electrical / Mechanical / Electronics Engineering trade **or** Matriculation with ITI in the Electrical / Mechanical / Electronics Engineering trades as an additional preferable qualification.(As ITI in the relevant trade is an additional qualification, matriculates without ITI in relevant trade can also apply).

Note: In the event of sufficient number of staff as at 2 (i) above not volunteering then only, staff volunteering in response to 2 (ii) in the order of priority will be considered for the post of Asst. Loco Pilot to make good the shortfall.

The volunteers should not be above 35 years of age for general category employees and not above 40 years in case of staff belonging to SC/ST as on 07.06.2021 i.e. date of notification. .

4. Volunteers who fulfill the above eligibility conditions may submit the application in the prescribed proforma, which is enclosed as Annexure 'A' along with attested copy of the Educational Qualification Certificate (from SSLC onwards) to concerned Supervisory officials on or before **05.07.2021**. The concerned Supervisory Official should forward the same in a bunch to this office on or before 11.07.2021. If, there is no volunteers a 'NIL' statement may be sent to this office.

5. The selection will be on basis of written examination, Aptitude test and assessment of Record of Service. The written examination will consist of one paper in professional ability as per Syllabus enclosed. The qualifying marks are as under:-

6. Volunteers who have passed in the written examination, have to undergo medical examination for **AYE ONE** medical classification and those found fit in **AYE ONE** only will be considered for Aptitude Test and who are qualified in the same will be placed on the panel for the post of ALP against 50% PRQ.

7. The Selection will be finalized entirely on Merit as per the instructions contained in RBE No. 113/2009 dated 19.06.2009 circulated vide PBC No. 121/2009 dated 07.07.2009 and PBC No. 54/2012 dated 18.04.2012 issued by PCPO/MAS.

8. Those who will be placed in the panel for the post of ALP will be sent for prescribed mandatory training course and those, who successfully complete the training will only be promoted as ALP in Level-2 (₹.19900-63200) against 50% PRQ and those who fail in the training will be sent back to their parent cadre.

9. During the training period, the volunteers will continue to receive the pay and allowances of the post from which they were selected.

10. Syllabus of the written examination for the post of Assistant Loco Pilot against 50% PRQ is enclosed as Annexure 'B'.

11. The questions will be 100% objective type with multiple choice questions as per RBE No. 196/2018 dated 14.12.2018, RBE No. 194/2019 dated 14.11.19 and PCPO/MAS letter No.P(R)608/P/Vol.III PBC No. 46/2019 dated 18.03.2019.

12. Wide publicity of this notification should be given to all the eligible staff under your control including those who are on deputation, leave/sick. Representations / applications received beyond the target date will not be entertained and the same should be disposed off at the unit level rejecting them on account of late receipt.

13. There will be NO SUPPLEMENTARY WRITEN EXAMINATION as this being calling volunteers.
