Jr. Clerk-Cum-Typist is non-Safety category pre-promotional training for SC/ST employees is not required.

The selection consists of written test as per Board's letter No. E(NG)/2018PM1/4 dated 14.12.2018 (RBE No.196/2018). The question paper will be 100% objective type multiple choice questions for the written examination and 10% of the total marks will be from Official language policy and rules. The questions on official language policy and the rules may not, however, be compulsory. In terms of PBC No. 08/2009, the employees should obtain 50% marks in the written test and 50% in the aggregate for being placed in the panel. In respect of SC/ST employees, 10% relaxation in qualifying marks is allowed against reserved vacancies, and accordingly they should get 40% marks in the written examination and 40% marks in aggregate for being placed in the panel against reserved post. The scheme of "Best among the failed "is also applicable for SC/ST employees as per extent instructions.

The Panel will be drawn in the order of Seniority amongst the qualified employees in terms of Rly. Board's letter No. E(NG)/2011/PM-1/26 date 05.05.2015 (RBE 43/2015).

The examination may be conducted in CBT mode or pen and paper test and as per RBE No 194/2019 dt. 14.11.2019, there will be **no negative marking** for incorrect Answers in selection against departmental quota where panel is arranged in the order of seniority from those qualified in written exam.

Selected employees will be deputed for prescribed training at MDZRTI/TPJ and after successful completion of training only they will be posted to the departments where the vacancies exist at the time of posting. It may also be notified to the employees that there will not be any supplementary examination under any circumstances, since the posts are filled by calling volunteers.

The Syllabus in connection with the above selection has already been advised this office notification ref. cited above.
