

Having accepted the terms and conditions stipulated in the offer of appointment issued by this office vide reference above, the candidates mentioned below are appointed as Goods Train Manager against compassionate grounds in Operating

Department of Salem Division on Stipend Pay Rs. 29200/- in Pay Matrix Level-5 plus other allowances admissible under rules from time to time. They are directed to report to attend the initial training course for Pro. Goods Train Manager commencing from

22.08.2022 to 22.10.2022 at MDZTI/TPJ

The appointment of the candidates is subject to the following terms and conditions:

1. The appointment is provisional and subject to verification of character and antecedents. In case of character & antecedents of the candidate is found not verified or any false information is given by the candidate in his self declaration, the provisional appointment orders will be canceled forthwith, and other criminal / legal action will also be taken as consequence.
2. He should attend the prescribed training for Pro. Goods Train Manager at MDZTI/TPJ and should join the course in proper uniform. If he do not complete the course successfully, OBC/UR candidates may be allowed a second change without stipend and SC candidates may be allowed a second chance with stipend, as per extant rules and if failed to qualify in the repeat course also, his services will be terminated.
3. In terms of Railway Board letter No.PC-V/2016/PS/I(Stipend)E dated 15.07.2022 (RBE No.83/2022) circulated vide PBC No.120/2022 dated 20.07.2022 during the training period they will be allowed to draw the monthly stipend of Rs.29200/- in PML-5.
4. The appointment is made on probation for two years after successful completion of training and after regular absorption.
5. His service is temporary and terminable on 14 days' notice on either side except that no such notice is required, if the termination of service is due to the expiry of sanction of post held by him or on return to duty of the absentee in whose place, he may be engaged in which case his service will be automatically terminated from the date of expiry of the sanction or from the date the former resume duty as the case may be. Also, no such notice will be required if the termination of service is due to his mental or physical incapacity or to their removal or dismissal as disciplinary measure

after compliance with provisions of clause (2) of Article 311 of the Constitution of India.

6. He will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to them.

7. His continuing in service is subject to:

- a. Qualifying for the duties prescribed for the post he hold.
- b. Fulfilling such other general conditions of service as may be laid from time to time.
- c. Being prepared to serve anywhere on Salem Division of the Southern Railway and
- d. Compliance to all rules and regulations as applicable to their appointment.

8. He will if, so required be liable for Military service in the Railway Engineering units, in the territorial Army service for a period of 7 years and 8 years in the Territorial Army reserve or for such period as may be laid down in this behalf from time to time.

9. The appointment is provisional and is subject to the correctness of the scheduled caste/Scheduled Tribe/Other Backward Community certificates being verified through proper channel and if the verification reveals that the claim belong to Schedule Caste /Scheduled Tribe/other Backward Community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificates.

10. He is required to serve in field, in allied or different from the one they are appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be altered covering different skills and fields in which she should be ready to serve; refusal to perform duty in this manner will make their liable for termination of service.

11. He will not be considered for Inter Divisional Transfer and Inter Railway transfer before completion of required period of regular service in the working post.

12. He will be governed by new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E)III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).

13. He will confirm to all Rules and regulations applicable to their appointment.

14. No Travelling (Daily) Allowance will be granted for joining the post.

15. In all other matters not specifically provided therein or on the Recruitment Rules, they will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.

16. His seniority will be assigned as per Indian Railway Establishment Manual Vol. I. Chapter III.
