

The appointment of the candidate is subject to the following terms and conditions:

1. The appointment is provisional and subject to verification of character and antecedents. In case of character & antecedents of the candidate is found not verified or any false information is given by the candidate in his/her self-declaration, the provisional appointment order will be cancelled forthwith, and other criminal / legal action will also be taken as consequence.
2. His/her appointment is subject to successful completion of initial training. The probation will be two years from the date of absorption of regular working post.
3. His/her service is temporary and terminable on 14 days' notice on either side except that no such notice is required, if the termination of service is due to the expiry of sanction of post he/she holds or on return to duty of the absentee in whose place he/she may be engaged in which case his/her service will be automatically terminated from the date of expiry of the sanction or from the date the former resumes duty as the case may be. Also, no such notice will be required if the termination of service is due to his/her mental or physical incapacity or to his/her removal or dismissal as disciplinary measure after compliance with provisions of clause (2) of Article 311 of the Constitution of India.
4. He/she will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to his/her.
5. His/her continuing in service is subject to:
 - a. Qualifying for the duties prescribed for the post he/she holds.
 - b. Fulfilling such other general conditions of service as may be laid from time to time.
 - c. Being prepared to serve anywhere on Salem Division of the Southern Railway and
 - d. Compliance to all rules and regulations as applicable to his/her appointment.
6. He/she will if, so required be liable for Military service in the Railway Engineering units, in the territorial Army service for a period of 7 years and 8 years in the Territorial Army reserve or for such period as may be laid down in this behalf from time to time.
7. The appointment is provisional and is subject to the correctness of the scheduled caste/Scheduled Tribe/Other Backward Community certificates being verified through proper channel and if the verification reveals that the claim belong to Schedule Caste /Scheduled Tribe/other Backward Community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificates.
8. He/she is required to serve in field, in allied or different from the one he/she is appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be altered covering different skills and fields in which he/she should be ready to serve; refusal to perform duty in this manner will make his/her liable for termination of service.
9. He/she will not be considered for Inter Divisional Transfer and Inter Railway transfer before completion of required period of regular service in the working post.
10. He/she is covered by the New Pension Scheme as per Railway Board's letter dt.13.12.04 communicated under PBC

No.22/2004.

11. He/she will confirm to all Rules and regulations applicable to his appointment.

12. No Travelling (Daily) Allowance will be granted for joining the post.

13. In all other matters not specifically provided therein or on the Recruitment Rules, he/she will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.

14. His/her seniority will be assigned as per Indian Railway Establishment Manual Vol. I. Chapter III.
