In terms of PCPO/MAS letter quoted above, Shri.A.Paramasivam,SCP was promoted as Ticket Examiner on out of turn on sports account duly relaxing the 3 years' service condition as well as the minimum educational qualification as per para 9.2.8 (a) of RBE No.02/2016 dated.07.01.2016.

Subsequently, he was promoted as Sr.CCTC in Pay matrix level-05 of 7th PC on provisional basis subject to verification of educational qualification- Hindi Bhasharatna (Inter Hindi Level) vide reference (3).

In terms of RBE No. 02/2016 dated. 07.01.2016 para No.9.2.8(b), "Sportsperson has to acquire the required minimum educational qualification within a period of four years, from the date of such promotion. Further promotion shall be considered only after acquiring such educational qualification".

In terms of reference (5), his certificate was sent to Maharashtra State Board of Secondary and higher secondary education for verification. On verification of his certificate, which is not equivalent to 10+2.

Hence, Shri.A.Paramasivam, Sr.CCTC/Inf/SA is reverted to the post of CCTC in Pay Matrix Level-03 of Pay matrix with immediate effect as under.
