Ref: 1. This office O.O.No.24/2022/TRANSPORTATION/GOODS TRAIN MANAGER/ CGA dtd. 18.08.2022.

The following candidate has been appointed through Compassionate grounds to the post of Goods Train Manager in L-5 of pay Matrix vide reference cited above. He attended the initial training course from 22.08.2022 to 22.10.2022 and has undergone Line training for Learning of Road from 23.10.2022 to 16. 11.2022 but he failed in the initial training course. He attended the repeat course of training for Goods Train Manager from 17.11.2022 to 10. 01.2023 without stipend and Learning of Road from 11.01.2023 and passed in the initial training course. He is absorbed as Goods Train Manager on Pay Rs.29200 in Pay Level-5 of Pay Matrix and posted at ED.

His appointment is subject to the following terms and conditions:-

1. His pay will be drawn from the date of assuming independent duty as Goods Train Manager at the place of posting.
2. He will be responsible for the government Money, Goods, Stores, and other properties that may be entrusted to him in the discharge of his official duties.
3. Candidates who joined Railways after 01.01.2004 will be governed by the new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E) III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).
4. The intervening period between the date of completion of training and the actual date of absorption is treated as an extension of training in terms of Rly.Board's Lr.No.E(NG) II/56/AK/1/4 dt.17.01.1969.
5. No request transfer for Inter Divisional/Inter Railway One-way transfer will be registered prior to the completion of three years of service on the regular working post i.e., after training in terms of PBC No. 60/2018 circulated by PCPO/MAS vide Lr.No.P(R)/676/P.Vol.VI dtd.09.04.2018.
6. He should be prepared to serve anywhere on the Railway system.
7. In all matters, not specifically provided herein or in the recruitment's rules, he will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
8. Seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Vol-I
9. The employees who are appointed against Compassionate Ground are required to maintain properly the other family

members who have been dependent on his/her father and in case it is proved subsequently that the family members are being neglected or are not being properly maintained by them, their appointment will be terminated forthwith without following the procedure prescribed in the Disciplinary Rules/Temporary Railway rules for this purpose.
