6. Supervisory official has to relieve the above-named employee immediately on receipt of this office order and is advised to report to this office to carry out his posting order.
7. As per RBE No.213/2000 dated 11.12.2000, the medically de-categorized employees who are now given alternative appointments have to carry out the orders for an alternative appointment immediately. No option is available to him to decline the alternative employment to which he is posted. If he does not take up the alternative employment immediately, the payment of salary to him against a special supernumerary post would be discontinued forthwith.
