

He is directed to report to Multi Disciplinary Zonal Training Institute, Tiruchirappalli on 06.03.2023 to undergo GRS Training.

His appointment is subject to the following conditions.

1. Candidate who joined Railways after 01.01.2004 will be governed by new pension scheme introduced by Railway Board vide letter No. F (E)III/2003/PNI/24 dated 31.12.2003.
2. He should undergo the prescribed period of training and pass the same successfully. If he do not complete the same successfully, UR/OBC candidates are eligible for second chance without stipend if considered necessary by the administration. If he fail in the second chance, he (UR/OBC) will be discharged from training. If SC/ST candidate fail in the initial training he is eligible for second chance with stipend if considered necessary by the administration. If the SC/ST candidates are fails in the second chance, they are eligible for third chance without stipend, if SC/ST candidates fails in third chance they will be discharged from training.
3. He will be on probation for a period of two (2) years from the date of absorption as temporary Assistant Loco Pilot and his confirmation will be subject to his satisfactory performance during the period of probation. If found un- satisfactory during the probationary period, his services are liable to be terminated on one month notice period in terms of IREM/Vol-I Chapter XV.
4. He will be responsible for the government Money, Goods, Stores and other properties that may be entrusted to him in the discharge of his official duties.
5. No change of category will be permitted for a minimum period of 3 years unless he is medically not suitable for the category.
6. He should be prepared to serve anywhere on the Railway system.

I/204225/2023 clearly understand that, his employment under government is temporary and his services may be terminated at any time without notice if such termination is due to expiry of the officiating vacancy in which he may be appointed or due to his removal or dismissal as a disciplinary measure after compliance with the provision of Article 311 of the constitution of India otherwise the appointment may be terminated at any time by 14 days of notice given by either side without any reason being assigned.

8.The appointing authority, however reserve the right of terminating his service forthwith or before the expiry of the stipulated period of notice by making payment to them or the sum equivalent to pay and allowance for the period of notice or the unexpired portion thereof. He should not resign or quit his employment except with the previous consent in writing of the Head of the department or office in which he is employed.

9. In all matters, not specifically mentioned herein or in the recruitment's rules, He will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.

10.No Inter Divisional / Railway transfer will be considered/registered unless he completes Three years of services.

11.This appointment order is purely provisional subject to the receipt of verification report from civil/police authorities regarding his character and antecedents. If anything, adverse in the said report is found regarding his suitability for appointment, his services are liable to be terminated forthwith without any notice.
