He should hand over all the railway material including the Medical Identity card to SS/ PLMD and he should vacate Railway Quarters if any in occupation.

He should vacate Railway quarters if in occupation as per extent orders. Retention of Railway quarters beyond the permitted period will be treated as unauthorized occupation and the following course of action will be taken against him.

i) Cancellation of allotment and eviction proceeding.

ii) Recovery of Damage rate of rent as per rules.

iii) Forfeiture of one set of post retirement complementary pass for every month of unauthorized retention of Rly. Qrs in terms of Railway Board's letter No.E(G)81/Qrs/5 dt.04.06.1994.

iv) The entire amount of DCRG will be with held for non-vacation of Railway quarters beyond the date of voluntary retirement.

He shall open necessary bank account for drawal of pension and other benefits. He should also obtain settlemt forms and hand over the same duly filled in within a fortnight from the date of issue of this office order.

The qualifying service of Shri. N. Sudhakar is 39 years 06 months and 06 days and it is certified by Sr.DFM/SA Lr.No. P.500/Sr.DFM/SA/PEN/Correspondence dated 06.01.2023.

He will not be permitted to withdraw his request for voluntary retirement under any circumstances at a later date.
